Meeting Called to Order

A regular meeting of the Forsyth County Board of Elections was called to order in the second floor Board room on Tuesday, October 12, 2021 at 5:00 p.m., Chairperson Durrah presiding.

Pledge of Allegiance

Chairperson Durrah led the Pledge of Allegiance.

Moment of Silence

Chairperson Durrah led a moment of silence.

Public Comments

Chairperson Durrah called for public comments; none provided.

Approval of Meeting Minutes

Member Draper moved to approve the September 28, 2021 meeting minutes as presented; Member Doomy seconded; **Motion carried unanimously**.

Approval of Absentee Ballots

Deputy Director Bobadilla presented the Board with two Absentee Ballots for review and approval. Secretary Jourdan moved to approve the two Absentee ballots, Member Doomy seconded; **Motion carried unanimously**.

Approval of Temporary Staffing Services Contract

Parkway United Methodists Church of Christ's request for the increase in fee for the use of their facility. Member Doomy moved to approve the \$50.00 fee increase for precinct 704 - Parkway United Methodist Church of Christ; Member Harvey seconded; **Motion carried unanimously**.

Approval of County Pay Plan and Premium Pay

Director Tsujii presented the County Pay plan and Premium Pay to the Board for review, discussion and approval. Member Doomy moved to approve the Resolution for the County Pay Plan and Premium Pay by way of the American Rescue Plan Act of 2021; Member Draper seconded; **Motion carried unanimously**.
