N.C. Secretary of State

The website contains general information and forms, including the <u>Articles of Incorporation</u> form. You can also search for corporation names. For assistance, call 919-814-5400.

U.S. Internal Revenue Service (IRS) Charities & Nonprofits

The IRS website provides comprehensive information and forms for nonprofits. Visit the website to apply for tax exempt status and obtain an Employer Identification Number (EIN). N.C. Department of Revenue (NCDOR)

GET ASSISTANCE AND INFORMATION

Forsyth County Public Library Nonprofit Resource Center (NRC)

The NRC, located on the third floor of Central Library, offers research materials on a wide variety of topics of interest to the nonprofit sector. From the library website, visit the <u>Business and Investing category</u>. Search ProQuest databases for journal articles or Candid's Nonprofit E-books collection for e-books to support your research. In addition, use <u>Foundation Directory Online (FDO)</u> to identify potential funding to support your nonprofit organization's mission and programs. HandsOn Northwest North Carolina

HandsOn offers both free and fee-based programs and classes, including sessions on nonprofit governance, management, and boards. They also offer individual consultations with staff to advise those who are considering starting their own nonprofit. Call 336-724-2866 for information.

Wake Forest University Community Law & Business Clinic

The Community Law Clinic is staffed with students of the Wake Forest University Law School and School of Business. Assistance is provided free of charge to small businesses and nonprofit organizations who are accepted as clients. Decisions to accept an engagement are made in the Fall and Spring semesters, and work is performed during the academic year (August through May). SEARCH FOR NONPROFIT ORGANIZATIONS

As an alternative to starting your own nonprofit, you may want to partner with an already existing organization. Use this list to find other nonprofit organizations that already do what you want to do.

GuideStar:

Search by state, city, type of organization, and keywords. Download the organization's 990 tax return filing. Sign in to get the most information from the website.

N.C. Secretary of State List of Nonprofit Corporations by N.C. Counties Choose the county, select all, and copy & paste into a spreadsheet.

IRS Exempt Organizations Business Master File Select the state, download the .csv file, and import into a spreadsheet.

IRS Exempt Organizations Select Check Search Select the search button and search by name and/or location.

N.C. Center for Nonprofits: Directory of Members Search by category and/or location.
