- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- Repair/replacement needed on leaking condensate on two door upright freezer (repeat), torn gasket on upright drink cooler, and missing kickplate in front of two door refrigerator in coffee station. Equipment shall be in good repair.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C- Detail cleaning needed on shelving units in snack bar kitchen, handles of all equipment, beef franks two door freezer, and upright coolers in snack bar kitchen. Clean at a frequency necessary to prevent accumulation of soil.
