Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 21 3-501.18 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Disposition - P - Philly steak (8-25) in upright cooler and tofu (9-2) in make-unit were both held past 7 days from preparation. Potentially hazardous foods shall be discarded 7 days from preparation if held at 41F or below. Ensure staff marks freeze dates and thaw dates to adequately keep up with how long potentially hazardous ready-to-eat foods have been under refrigeration versus in the freezer. CDI - Both items discarded.
- 31 3-501.15 Cooling Methods - PF - Chicken wings cooling in upright cooler and salads at Chick-fil-a cooling in containers in upright cooler. Potentially hazardous foods shall be cooled in equipment that is designed to rapidly cool foods such as the walk-in cooler. Potentially hazardous foods must also be left uncovered or loosely covered when cooling. CDI - Both items moved to walk-in cooler and salad containers' lids were popped off.
- 41 3-304.12 In-Use Utensils, Between-Use Storage - C - Scoops at salad station were stored in dipper well that was turned off. In-use utensils shall be stored in water above 135F, in the ingredient or food with the handle not touching the food, or in dipper well that is draining and agitates food particles off the utensil by spraying. CDI - Scoops taken to be rewashed. 0 pts.

Repair/replace all listed equipment.
- 51 5-501.17 Toilet Room Receptacle, Covered - C - Repeat - Employee restroom needs a covered receptacle. Place trash can with lid in employee restroom.
