- C. Supplier price increases on Filter Cloth were reviewed by the board. Recent increases in gravel costs should be submitted to the TRC for consideration.
- D. Kerry Venable would like all members of the Board and Staff of FSWCD to reach out to serve small farmers as well as large farmers. Other counties who have seen the newsletter made comments on receiving useful information. Kerry Venable would like to see 90% contracts for smaller farmers (gross sales under \$100,000 per year and income not to exceed \$55,000 per year). Kerry Venable would like Randy to take a look at James Scales and Vern Switzer.
