Cleaning needed on shelves above three compartment sink where dust has built up. Non food contact surfaces shall be maintained clean.
- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C Men and women restroom handsinks need to be recaulked to the walls. Oven hood needs to be recaulked to the wall where it is peeling. Vinyl cover in can wash is warped with water underneath, replace or repair vinyl cover. Walls in can wash need to be repainted where paint is peeling. Ceiling grid is loose in back above can wash are and needs to be repaired to be smooth. One ceiling tile loose in mens restroom, re adjust to be smooth with ceiling. Floors, walls, and ceilings shall be in good repair to aid cleaning. // 6-501.16 Drying Mops - C Repeat: Mops hanging in can wash upside down. Mops shall be stored with heads to the ground so water may not contaminate the handles of the mops.
