- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P Bottle of quat sanitizer used to sanitize slicer tested 0PPM on testing device. Bottle filled directly from 3 compartment sink. Maintain sanitizer as specified under 7-204.11. CDI. Adjustments made to dispenser at 3 compartment sink. Bottle refilled from 3 compartment sink. Now 300PPM. Recommend calling Ecolab to adjust dispenser at 3 compartment sink to make sanitizer dispenser easier for employees to operate.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P Three sandwiches (ham and turkey) in retail case 46-47F. Two other sandwiches 42-45F. Sandwiches prepared and stocked 4 hours previously. Potentially hazardous food shall be cold held at 41F or less. Addition of new plastic shelving possible cause of interference with food temperatures. Air temp of unit 40F. CDI. Three sandwiches holding 46-47 discarded. Other sandwiches rearranged in cooler to bring down temperature. Plastic partition removed from cooler.
- 38 2-402.11 Effectiveness-Hair Restraints - C Repeat violation. Employee observed packaging chicken wraps without hair restraint. Food employees shall wear effective hair restraint when handling food or clean dishes and utensils.
