- 6 2-301.14 When to Wash - (P)/2-301.12 Cleaning Procedure - (P)- Approximately three employees washed hands using proper procedure but used bare hands to turn off faucet handles. Employees shall wash hands after changing task, going from raw to ready to eat products and before donning new gloves. Physical barriers such as a paper towel shall be used to turn of faucet handles to avoid recontamination of hands . CDI- employees were addressed, employees rewashed hands.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - (P)- roast beef container was over stacked. Top half had a temperature of 50 degrees but bottom half was 40 degrees. One container of tomatoes had a temperature of 45-50 degrees. Potentially hazardous foods shall be held at 41 degrees or below. CDI- Roast beef out of temperature was voluntarily discarded. PIC stated tomatoes were just cut. Tomatoes were cooled to 41 degrees.
- 26 7-102.11 Common Name-Working Containers - (PF)- One container holding glass cleaner was not labeled. Working containers used for storing poisonous or toxic materials such as cleaners and sanitizers taken from bulk supplies shall be clearly and individually identified with the common name of the material.
