National Day to Prevent Teen Pregnancy

Every day in Forsyth County, two teens between the ages of 15-19 become pregnant

- Forsyth County now ranks #25 out of our 100 counties for the highest teen pregnancy rates
- ❖ 50% of our WS/FC high school students report having had sexual intercourse and only 63% of sexually active students used a condom during their last sexual intercourse
- ❖ Only 40% of mothers who have children before age 18 graduate from high school

Driving Directions

Truliant Federal Credit Union Pavilion 3200 Truliant Way, Winston-Salem, NC

From East:

From Greensboro, take I-40 West to Hanes Mall Blvd. Exit 190. At end of ramp, turn right. Go to the first stop light and turn right onto Truliant Way.

From West:

From Statesville, Take I-40 East and Exit at Stratford Road, Exit 189. At end of ramp, turn right. Go to second light and turn left on Hanes Mall Blvd. Go to sixth stop light and turn right onto Truliant Way.

From North:

Take Silas Creek Parkway south to Hanes Mall Blvd. Turn right. Turn left at 2nd light onto Truliant Way. Or:

Take 52 South to I-40 West Exit 107B. Travel to Hanes Mall Blvd. Exit 190. At end of ramp, turn right. Go to the first stop light and turn right onto Truliant Way.

From South:

Take 52 North to I-40 West Exit 107B. Travel to Hanes Mall Blvd. Exit 190. At end of ramp, turn right. Go to the first stop light and turn right onto Truliant Way.
