- 26 7-102.11 Common Name-Working Containers - PF - Container of salt melt for parking lot not labelled. All containers of toxic chemicals shall be labelled. CDI - Container labelled by manager. 0 pts.
- 39 3-304.14 Wiping Cloths, Use Limitation - C - Some wiping cloths had visible food residue on them and 1 container of sanitizer used to wipe milk steamer had visible soil in the solution and needed to be changed. Wiping cloths used to wipe counters and other equipment surfaces shall be free of food debris and visible soil. Sanitizer solution shall also be maintained free of any visible soil. Change out wiping cloths and sanitizer buckets once they become soiled.
