1. Approval of Minutes for Meetings of February 11, 2008 and February 25, 2008

Commissioner Whiteheart moved for approval of the Minutes for the meetings of February 11, 2008 and February 25, 2008. Commissioner Bailey seconded the motion, which was unanimously approved.

2. Approval of Releases in Accordance with G.S. 105-381

Commissioner Kaplan moved for approval of the Releases through February 29, 2008. Commissioner Linville seconded the motion, which was unanimously approved.

3. PUBLIC SESSION

Persons Who Wish to Speak Concerning Items on this Agenda, or Who Wish to Speak About a Matter Relating to County Government (Other Than a Public Hearing Matter on this Agenda), should Complete a Speaker Card and Hand it to the Clerk Before the Meeting Begins. It is not Necessary to Complete a Card if You are Going to Speak about a Public Hearing Matter on this Agenda. The Chair may Limit the Number of Speakers on a Topic Relating to Future Advertised Public Hearing Matters. Speakers are Limited to Three (3) Minutes Each. The Public Session will be Limited to 30 Minutes.

John Sangimino spoke regarding Extra Territorial Jurisdiction for Lewisville. Mr. Sangimino indicated that growth can't be stopped. However, he expressed the desire to keep the rural character of his community.

Mary Annicelli, a mental health advocate, spoke regarding financial accountability at CenterPoint Human services. Ms. Annicelli distributed a handout regarding the audit of CenterPoint by an outside contractor.

Laurie Coker addressed the Board regarding funding for CenterPoint. Ms. Coker made references to the handout distributed by Ms. Annicelli.

Emma Thorne, a member of NAMI (National Alliance on Mental Illness), spoke regarding the lack of beds for mentally ill individuals in our area.

Jimmy Morgan, a member of the HOT (Heart of the Triad) Stakeholders Committee, spoke as a private citizen. Mr. Morgan expressed the opinion that the spending for the HOT area should not be at the expense of other governmental responsibilities.

Cathy M. Poole said she had attended a HOT meeting and was refused access to view certain records. Ms. Poole said that the refusal is in violation of public records laws. She asked that residents in HOT be allowed to participate in the planning process.

Billie Gilfillan said she had attended a CenterPoint Board meeting on February 28, 2008. Mrs. Gilfillan said that dropping *all* advisory committees was discussed at that meeting. She expressed opposition to the idea.

In response to Commissioner Marshall's inquiry as to how the situation with CenterPoint might be addressed locally, the County Manager suggested that perhaps an expert from the School of Government could meet with Board to discuss the matter in order to determine what options the Commissioners might have in reference to CenterPoint.

4.
