



RESTRICTED POLLING PLACES DURING ELECTION DAY

The non-public voting place locations listed below allow the use of their facilities on a voluntary basis. As part of our present agreement, some locations have requested that no literature be distributed and that no signs be placed on their property. Others have requested that no signs be allowed but will allow literature to be distributed. Pursuant to G.S. 163-166.4, a special agreement for electioneering restrictions at the polling places listed below has been approved upon by the Forsyth County Board of Elections and the Executive Director of the State Board of Elections. The Board of Elections respectfully requests that all candidates honor this agreement in order that the continued use of these voting places is not jeopardized. Candidates should contact the Board of Elections prior to Election Day if there are any questions. All election officials have been instructed to enforce this arrangement at each voting place.

We wanted to make you aware that due to recent law changes (S.L.2019-119) candidates shall be allowed to place campaign signs at the polling place 36 hours before the voting place opens and retrieve the signs 36 hours after the close.

RESTRICTIONS AT ALL VOTING PLACES:

The North Carolina General Statutes 163-166.4(a) states that “No person or group of persons shall hinder access, harass others, distribute campaign literature, place political advertising, solicit votes, or otherwise engage in election-related activity in the voting place or in a buffer zone which shall be prescribed by the county board of elections around the voting place. In determining the dimensions of that buffer zone for each voting place, the county board of elections shall, where practical, set the limit at 50 feet from the door of entrance to the voting place, measured when that door is closed, but in no event shall it set the limit at more than 50 feet or at less than 25 feet”. The Forsyth County Board of Elections has set the buffer zone at 50 feet for all precincts.

Please remember that **it is the responsibility of each campaign organization to clean up all literature and signs around the voting place after the polls close on election night.** Should you have any questions concerning the information about the precincts, please contact the office.

REMINDER — the only persons allowed inside the voting enclosure are Board of Election officials, voters in the act of voting, authorized observers, a voter assisting another voter and a voter challenging another voter. The voting enclosure includes the area of the ballot counter, registration table and voting booths.

OBSERVERS/RUNNERS:

Duly appointed observers and runners are allowed in each polling place to make observations and to take notes. The party chair must notify the Board of Elections of the names of all observers and runners to be used in each precinct before 10:00 AM on the fifth day before Election Day. They must be registered voters in the county. No person who is a candidate on the ballot in a primary or election may serve as an observer or runner in that primary or election. NCGS 163-45(c) states that “An observer shall do no electioneering at the voting place and shall in no manner impede the voting process or interfere or communicate with or observe any voter in casting a ballot, but, subject to these restrictions, the chief judge and judges of elections shall permit the observer to make such observation and take such notes as the observer may desire.” A party chairperson or unaffiliated candidate whose name is on the ballot or the unaffiliated candidate’s campaign manager may recommend observers and runners to the Board of Elections.

Observers may inspect the ATV forms and make a list of the names of people that have voted. This may be done “at times specified by the State Board of Elections, but not less than three times during Election Day with the spacing not less than one hour apart.”

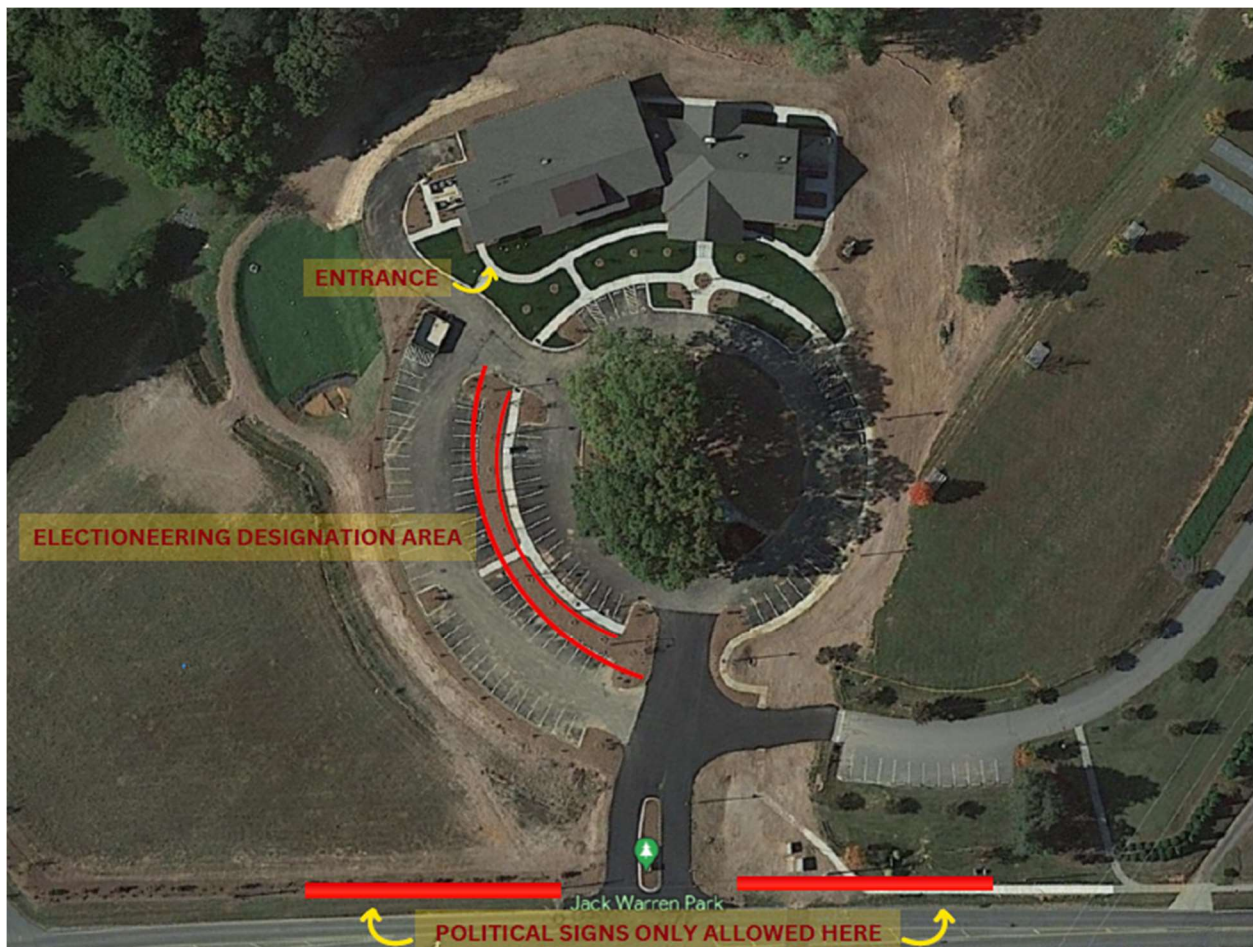
Instead of having an observer receive the voting list, the county party chair may send a runner to pick up the list of voters from the precinct. Forsyth County uses Authorization to Vote forms; therefore, there is no prepared list for a runner to pick up. Runners assigned to a precinct may receive a voter list from the observer at the precinct on the same schedule as an observer. Each party is entitled to only one voter list at each of the scheduled times. Runners may enter the voting enclosure to announce their presence and to receive the voting list. A runner must leave immediately after receiving the list. If you want observers or runners, please contact your party chairperson.



ELECTIONEERING DESIGNATION AREA FOR MARY ALICE WARREN COMMUNITY CENTER

The voting place location listed below allow the use of their facilities on a voluntary basis. As part of our present agreement, some locations have requested that electioneering take place in a designated area at the voting site. The Board of Elections respectfully requests that all candidates voluntarily honor this agreement in order that the continued use of these voting places is not jeopardized. Candidates should contact the Board of Elections prior to Election Day if there are any questions. All election officials have been instructed to enforce this arrangement.

For all voting sites, we wanted to make you aware that due to recent law changes (S.L.2019-119) candidates shall be allowed to place campaign signs at the polling place 36 hours before the voting place opens and retrieve the signs 36 hours after the close.

RESTRICTIONS AT ALL VOTING PLACES:

**Electioneering Designation Rules for the
Forsyth County Government Center Building**

1. In accordance with NC General Statute 163-166.4(a)(b), the Forsyth County Board of Elections, working with Forsyth County Government, has identified and designated the areas in the attached maps as buffer zones and adjacent electioneering zones within the Forsyth County Government Center Parking Deck and the front of the Forsyth County Government Center Building. (See Addendum A - 1st Level Parking Deck and Addendum B- Government Center Main Entrance)
2. No campaigning should be done outside the designated areas.
3. Under no circumstance should a campaigner hinder the flow of traffic in or out of the parking deck, including walking in front of, beside or behind vehicles.
4. No signs shall be placed in the drains on County property. No signs shall be taped to any poles, rails or posts located on County property.
5. Any campaigner needing to communicate with other campaigners in another location must walk outside the building and not enter the Government Center.
6. Campaigners who bring chairs or other stationary items can not impede the flow of voter/customer traffic at either entrance. Chairs can only be placed in the area designated for stationary items in the front of the County office building or the electioneering zone in the parking deck.
7. Any campaigner who violates these rules will be given a verbal warning. If the behavior persists, the campaigner will be reported to the appropriate party or candidate's committee for correction. Further violation will result in the campaigner being asked to leave the facility. The areas will be closely monitored by Forsyth County security staff and early voting workers.

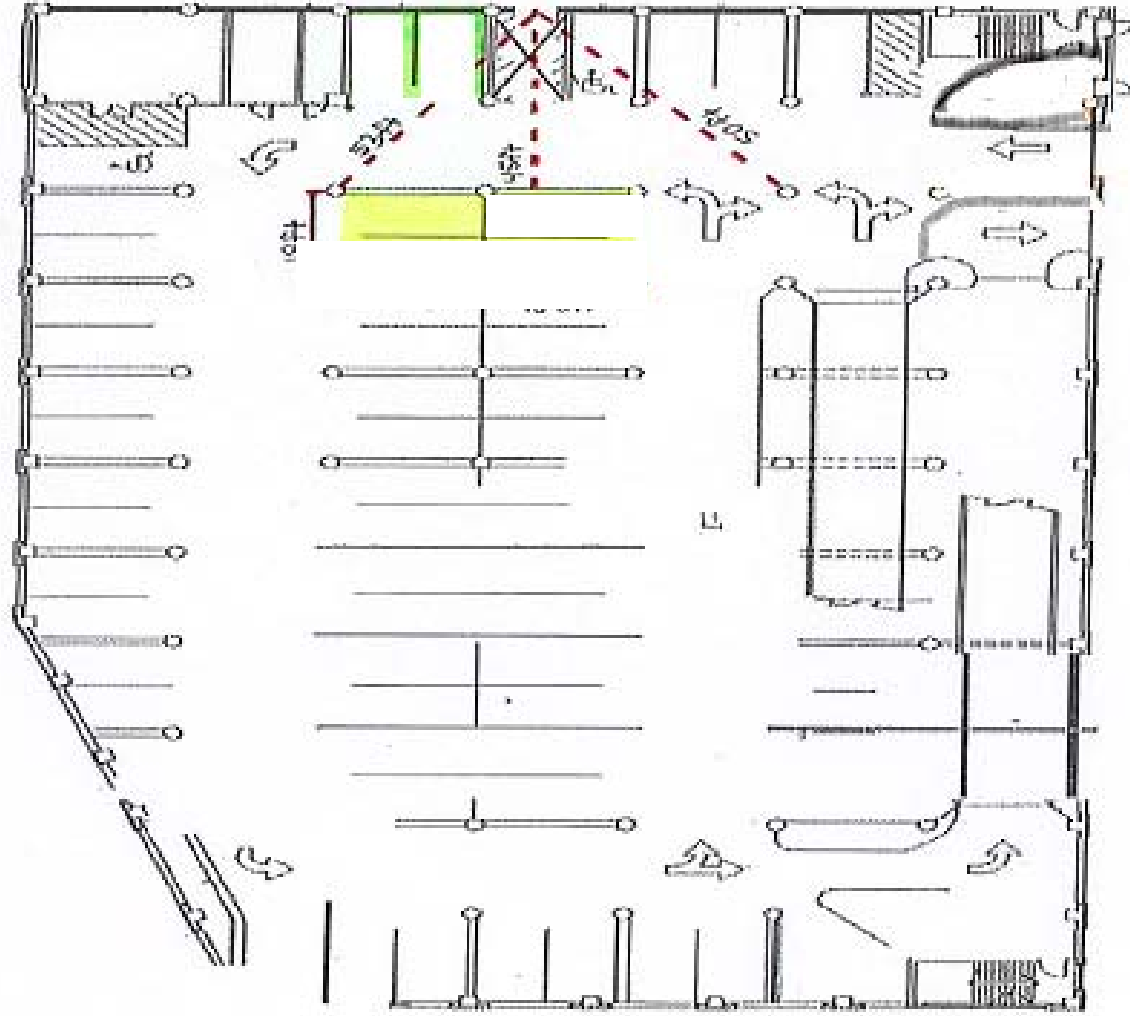
Forsyth County
