

Forsyth County Sheriff's Office Animal Services Division Annual Report 2020

The purpose of this report is to provide statistical information to the Forsyth County Animal Services Advisory Board. It may assist the Advisory Board with advising the Forsyth County Board of Commissioners on issues and needs related to animal protection and services in Forsyth County.

The Forsyth County Animal Control Advisory Board is an eleven (11) member board identified in Forsyth County Code (FCC) Chapter 6, Sec. 6-5, Animal Control Advisory Board. The Advisory Board makes recommendations on animal control codes, policies and programs related to animals. Members are appointed by the Board of County Commissioners pursuant to identified interest categories. The Advisory Board conducts regular public meetings and prepares an annual report for the Board of County Commissioners. Pursuant to FCC Chapter 6, Sec. 6-5, the Advisory Board has adopted by-laws governing the purpose, duties, operations and membership subject to the approval of the County Manager.

Work Plan

Calendar year (CY) 2020 was a different kind of year with the onset of COVID-19 initially closing down and then drastically altering how all businesses work. Animal Services worked in unison with our partner agency, the Forsyth Humane Society, to make sure we were still able to provide a high level of service to our citizens with little to no interruption. We claim 2020 as a success when having to work through all the new challenges we faced.

The Advisory Board adopted a multi-tracked work plan to provide organization and focus to its meetings, in addition to its mandate to act as a Hearing Tribunal. During the 2020 calendar year, the Advisory Board discussed issues pertaining to the low compliance rate of pet licensing and the possible elimination of this requirement, as well as changes to FCC 6-57 regarding the stay of enforcement of violations, specifically related to Potentially Dangerous and Dangerous Dog Declarations while the violation is in the appeal process. They also discussed North Carolina state regulations related to who is allowed to give a three year Rabies vaccination and possibly working with state legislators on getting this requirement altered.

Forsyth County continued to contract with the Forsyth Humane Society for care, custody and adoption of all cats and dogs, as well as performing euthanasia of animals that were not appropriate for adoption due to various reasons.

The Advisory Board continued working with the Animal Services Division on Hearing Tribunals making sure backlogs experienced in previous years did not occur. Currently, appeals are being heard on average within 4-6 weeks of receipt. In CY2020, the Advisory Board heard 85 appeals that encompassed 271 violations. Of these appeals, 159 violations we upheld with 112 violations being dismissed. Potentially Dangerous and Dangerous Dog declaration appeals in CY2020 were heard at the next available hearing date which averaged to be 4-6 weeks from the date of the declaration being issued.

Even with COVID-19 altering business plans, the Animal Services Division continued hosting low-cost rabies clinics CY2020. Rabies clinics took a new format in CY2020 with our staff considering ways to vaccinate pets while reducing the number of people gathering so that the spread of COVID-19 to our staff members was reduced or eliminated. We chose to implement a drive-thru model where owners and pets remained in their vehicles for the vaccine. This model proved to be a positive change as it eliminated all of the confusion, anxiety, and apprehensiveness felt not only by the animal, but the owner as well. Four clinics were held during the year with one in June, July, August, and November respectively. The Animal Services Division plans to continue with the popular and successful drive-thru model for all rabies clinics planned in CY2021.

The initiative to get more pets spayed/neutered continued with \$10 spay/neuter vouchers being offered in March through an appointment only process. This eliminated the time pet owners spent at the shelter filling out paperwork and a mass gathering to assist in reducing the spread of COVID-19.
