
FORSYTH COUNTY BOARD OF ELECTIONS

Petition Request Form

- Voters interested in running as an Unaffiliated candidate for an office are required to provide a completed petition request form to the County Board of Election or State Board of Elections, whichever oversees the jurisdiction of the office they will be petitioning.
- The County Board of Elections will set up the signature collection form with the necessary information to ensure proper verification of signatures collected. This may be provided to the candidate via email for their use.

Exceptions:

- Candidates whose name appeared on a primary ballot will not be eligible to file as an Unaffiliated candidate for the General Election.
- Unaffiliated petitioners are not required to be registered as an Unaffiliated voter to petition as an Unaffiliated candidate; the petitioner would not be representing their official party of registration on the ballot.

- All signatures collected must be original signatures by registered voters in the respective jurisdiction. Electronic signatures will not be accepted.

Qualifying Signatures

When collecting signatures - signers must be registered voters in the jurisdiction that the seat will serve and signers must sign in their hand or make their mark in the event they are not able to sign their name. The link below will enable anyone collecting signatures to verify signers is registered to vote as well as verify the jurisdiction in which they are registered to vote.

Voter Search (ncsbe.gov)

It is the petition holder's responsibility to understand the boundaries of the seat they are petitioning for and the addresses that fall within that jurisdiction. Multiple links are available on the next slide that will enable jurisdiction verification.

2021 & 2022 – Redistricting Exception

- Regarding districts that may be affected by redistricting, if a petition was started before new or redrawn districts became finalized and includes signatures of those who no longer reside in the district as a result of the new district lines, the counties may only count signatures of those who reside in the new district.
- Further, if the petitioner is no longer living in the district because of the changed lines, he or she will not meet the requirements to be a candidate in that district; they also may need to fill out a new Petition Request Form for the revised district lines.
- Unaffiliated Congressional Candidate' residential requirements differ from local candidates and are asked to check with the State Board of Elections on how the redistricting would impact their petition.

- MapForsyth also offers address searches in real time to verify any addresses' position within the ward, city, county, school district, NC Senate and NC House district. It is accessible 24 hours a day, 7 days a week.

Petition Signature Status

- Only registered voters' signatures are counted toward the total number of signatures required for the ward, city, county, school district, NC Senate and NC House district that the petition is applicable to. Voters can withdraw their signatures prior to petition being finalized.
- The name, address and the signature in the voter's own hand are required. Information is compared against the voter registration on file. Each signature is examined, and a signature status is entered into the Petition Module; which will track the approved signatures throughout the petition verification process.
- Citizens that are not registered or those that have an address change are mailed a letter to enable them to register to vote or to updated the voter information provided on the petition.

Signature Status Legend

- Address Rejected (AR) – The address does not meet the requirements for the boundaries of the Ward, City, County, District or State office the petitioner will serve.
- Deceased (DEC) – The name and address belong to a deceased voter.
- Illegible (I) (Not Clear to Verify) – The name, address, signature are unable to be deciphered to allow any match to be located in the petition module.
- Late Filing (LF) – This is used for petitions that are received after the submission deadline – it does allow for non-registered voters who signed to receive a voter registration form and it allows for those that are registered but have a different address to receive a verification letter of the change presented on the petition form. The signatures will not count toward the petition total.
- Moved (M) – The address presented on the petition is different from the address of their voter registration and no longer reside in the Ward, City, County, State or Congressional districts of the petition.
- No Record (NR) – There is no record of voter registration on file for the signer.
- Not in District (ND) – The signer does not reside in the district that the office of the petition holder is gathering signatures for.
- Removed (R) – Voter has been removed according to list maintenance requirement; this could be moved from county; moved from state; removed after not voting after 2 Federal Election Cycles.
- Incorrect County (IC)– The petition signer is not registered in the county affected by the petition.
- Signature Missing (SM) – Petition signer did not provide the signature with their information.
- Signature Rejected (SR)– The signature provided has no resemblance to the signature on file.
- Signature Withdrawn (SW)– This happens when a petition signer strikes out their name and signature from the petition.
- Wrong Party (WP) – Generally for the certification process of Third-Party Petitions.
- Ok (ü) – Meets all criteria for signature to count toward petition signature requirement, signature matches voter registration, and residence within city, ward, county or district boundaries according office sought.

Petition Certification

- Once the signature verification process is completed and the petition total has been verified, the verified signatures are presented to the appropriate State or County Board of Elections for certification.
- Petitions will only be certified if the required numbers of signatures set forth by statute are obtained.
- Upon certification the candidate will then file a Notice of Candidacy, pay the filing fee and their name will then appear on the ballot for the General Election along with any other candidates for the race in which they petitioned.

Campaign Finance

Campaign Finance obligations are the same for all candidates running for an office or seat. The office being sought will determine whether or not the petition holder or now candidate will be able to file: Over Threshold or Under Threshold.

All committees that file Over Threshold will be required to submit the appropriate reports based on the election cycle. If the petition holder has started the petition process prior to the actual election cycle that their name will appear on the ballot, they will be responsible for Mid-Year and End of Year reports and will switch to quarterly reports in the active election cycle.

If the office or seat qualifies to file as Under Threshold there will be no Disclosure Reports due until which time the committee meets or exceeds \$1,000.00 in contributions or expenditures. Yearly Under Threshold re-certifications will be required to remain Under Threshold. Candidate contributions do count toward the threshold limit.
