While Old Salem has made progress in including stories and testimonials of enslaved individuals in exhibits and tour narratives, there is still much work to be done, particularly in refurbishing buildings that were important to the lives of the enslaved individuals and opening them to visitors as part of the official Old Salem tour experience. The replica of the original St. Philips log church, the current brick St. Philips church, as well as two barns and the former Tavern where the enslaved worked and slept, are in dire need of major
