Timeline

November 8, 2016

Parks & Recreation Facilities Bond including \$5 million dollar allocation for Multi-Use Agricultural Event Center(MUAEC) passes by a margin of 71% “for” to 29% “against.”

January 2017 - December 2018

- County staff considered county-owned properties as potential MUAEC sites.
- Similar NC facilities–their features, uses, and financial performance–were reviewed.
- Municipal partnerships were explored.

February 2019

Winter work session presentation on MUAEC concepts and potential sites, emphasis on Tanglewood sites.

February 2021

Tanglewood site explored as destination of MUAEC; RFQ published for Design/Build team.

May 2021

Design/Build firms considered to develop and ultimately construct MUAEC project.

Staff report to County Commissioners on in put received regarding proposed Tanglewood site

October 2021

Commissioners direct staff to seek a location other than Tanglewood for the MUAEC.

February 3, 2022

County Management present Rolling Hills site to regular meeting of Village of Tobacoville Council.

March 15, 2022

1st Public input session at Tobacoville Community Center on County's "Rolling Hills" site.

March 30, 2022

2nd Public input session at Tobacoville Community Center on County's "Rolling Hills" site.






Answer Options	Response Percent	Response Count

378 Total Survey Responses

217 or **57%** of respondents were specifically “In Favor” of the Multi-Use Agricultural Event Center Location at the County’s “Rolling Hills” property.


292 or **77%** of respondents were either “In Favor,” “Unsure,” or “Neutral” but not “Against” the Multi-Use Agricultural Event Center Location at the County’s “Rolling Hills” property.

86 Respondents or **23%** identified as specifically “Against” the Rolling Hills location or the concept of a Multi-Use Agricultural Event Center.




