Wetwiping cloths used for wiping equipment shall be held in between use in a chemical sanitizer with a concentration as specified in § 4-501.114; 150-400ppm for quat sanitizer. 0.5pts
- 52 5-501.114 Using Drain Plugs - C- Drain plugs are missing on outside cardboard dumpster. Contact Waste Management for replacement of drain plugs. Receptacles shall have drain plugs. 0pts
- 54 6-303.11 Intensity-Lighting - C-REPEAT- Low lighting was observed in the following areas: 4-10ft candles at the 3 compartment sink; 33-39ft candles at the coffee brewing station; 31-38ft candles at the sandwich station; 3-6ft candles in women's restroom; and 9-12ft candles in men's restroom. Lighting shall be at least 50ft candles in food preparation areas and at least 20ft candles in restrooms and warewashing areas. Replace broken light bulbs and evaluate other light bulbs for light intensity. 0.5pts
